1. Important American Board of Preventive Medicine (ABPM) Changes

Some licensing boards are now requiring Maintenance of Certification (MOC) for all renewals even for individuals with lifetime certifications. In addition beginning in August 2011, ABMS member boards will be required to report the MOC participation status of all diplomats, including those with lifetime certificates. Registering for MOC is easy and costs 200 dollars. The current requirements are here – <u>https://www.theabpm.org/moc/moc_requirements.cfm</u>. As a quick summary you need to be licensed, to take MOC and CME credits, to take a cognitive test in years 7 to 10 and to provide an assessment of practice performance which can include a portfolio for those of us who don't see individual patients.

2. Membership Website Continues to be built up

CDC Health Disparities Report

CDC has released the <u>CDC Health Disparities and Inequalities Report, United States, 2011</u>, which examines the differences in health outcomes between population groups that reflect social inequalities. This MMWR Supplement is the first in a periodic series examining health disparities in the United States. The report provides an overview of key social determinates of health, including education and income, inadequate and unhealthy housing, unhealthy air quality, and health insurance coverage. 4. Tobacco Report

The FDA has not yet ruled on the American Association of Public Health Physicians, Tobacco Control Task Force (AAPHP) - Citizen Petition submitted over one year ago on February 7, 2010 which requests that the FDA regulate e-cigarettes as tobacco products The document is still open and available for comment by members who have opinions on the issue of regulation of e-cigarettes. On January 24, 2011 the U.S. Court of Appeals for the District of Columbia Circuit rejected the FDA's request to have the entire court review the December decision by a three-judge panel that ruled that "FDA has authority to regulate customarily marketed tobacco products-including e-cigarettes under the Tobacco Act.

It has authority to regulate therapeutically marketed tobacco products under the FDCA's drug/device provisions" Regulation as tobacco products would not require removal from the market pending additional research. Regulation as tobacco products would require that good manufacturing practices be used and that these products not be marketed to children. The current decision stands unless the Supreme Court accepts and then overturns that decision. 5. Report from Preventive Medicine 2011 - Tobacco - Free Policies Session

Current Co-Chair Virginia Dato MD MPH attended a session at Preventive Medicine 2011 session called "Tobacco-Free Policies: Moving beyond the Indoor Environment. Stan Glantz PhD presented evidence about the dangers of indoor second hand smoke. Robert Berger MS discussed some of the policy interventions in California which include banning smoking at beaches. Philip Huang MD MPH Medical Directory of the Health Authority Austin Travis County Health Department provided information on their Tobacco Free Initiative and made it clear that their initiative included all smoke free tobacco products in addition to cigarettes. When asked for the justification as to dangers to others,, the response was that this was part of the Gold Standard Initiative for worksites. To the credit of the Gold Standard initiative .

6. Reprint from Americans for Non - Smokers Rights

Today ANR gave a national award to Avis Budget Group, which is the owner of the Avis and Budget rental car brands, for the company's smokefree policy covering their rental cars in the U.S., Canada, U.S. Virgin Islands, and Puerto Rico.

This is the first fleet-wide smokefree rental car policy to be enforced with a \$250 cleaning fee. Avis Budget Group management described the move as a sound business decision, citing residual secondhand smoke in their cars as their number one customer complaint.

Additionally, Avis Budget Group recently announced that all their facilities and properties will be 100% smokefree starting in April 2011. They have also ramped up efforts to help their employees quit smoking.

"It's great that this company has stepped up as a leader and has set a positive example for other businesses to follow," said Cynthia Hallett, Executive Director of Americans for Nonsmokers' Rights. "Today a number of their front -line employees said that they experience less exposure to secondhand and thirdhand smoke, thanks to the new smokefree policy."

9. News Updates from NACCHO

Results of Local Health Department Job Losses Survey Demonstrates Depth of Program Cuts

29,000 local health department jobs lost since January 2008, threatening essential services

Washington, DC (March 21, 2011) – A recent survey analysis found that roughly 19 percent of the nationwide local health department workforce has been eliminated since 2008, posing a staggering challenge to local health departments striving to keep Americans safe and healthy in the face of increasing staff and program cuts, even as the country's economic slump increases demand for services.

Highlights from the 2010 survey results, released today by the National Association of County and City Health Officials (NACCHO), reveal that 6,000 local health department jobs were eliminated last year, bringing the total number of local health department jobs lost since 2008 to 29,000. In addition to the layoffs, 18,000 local health department employees were subjected to reduced hours or mandatory furloughs.

Federal, state, and local budget reductions have also reduced available services. Forty percent of local health departments reduced services in at least one program area between mid-2009 and mid-2010. Maternal and child health programs were among the hardest hit, with nearly one in every five local health departments (18%) reporting reduced or eliminated services to pregnant women, new mothers and children. Population-based primary prevention, environmental health programs, and clinical health services were also among the most common targets for cuts.

"Protecting and defending the health of residents in local communities and meeting their expectations for service is increasingly difficult," said NACCHO Executive Director Robert M. Pestronk. "These annual budget cuts and job losses threaten the ability of local health departments to prepare for and respond to emergencies, and provide basic services that all individuals and families count on. The future of our nation's health is jeopardized."
